



**A RESOLUTION DECLARING HATJR-MAINTENANCE & CONSTRUCTION SERVICES CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE DESIGN AND BUILD SCHEME INFRASTRUCTURE PROJECT: COMPLETION OF WATER SYSTEM AMOUNTING TO EIGHT MILLION FOUR HUNDRED NINETEEN THOUSAND SEVEN HUNDRED TWENTY-SEVEN PESOS AND 14/100 CENTAVOS (₱8,419,727.14) AND RECOMMENDING FOR THE APPROVAL OF THE CONTRACT BY THE HEAD OF THE PROCURING ENTITY**

**BAC RESOLUTION NO. 2020-11-081**

- WHEREAS**, the PSHS-MRC has an allotted amount under the General Appropriations Act 2020 for the project, **DESIGN AND BUILD SCHEME INFRASTRUCTURE PROJECT: COMPLETION OF WATER SYSTEM**, amounting to **TEN MILLION PESOS (₱10,000,000.00)**;
- WHEREAS**, the Department of Budget Management issued the **National Budget Circular No. 580** dated April 22, 2020, "**Adoption of Economy Measures in the Government due to the Emergency Health Situation**," the allotted amount for the project was reduced to **₱8,612,564.00**.
- WHEREAS**, during the Pre-Procurement, PSHS-MRC Bids and Awards Committee with the assistance of the Engineering Team computed the estimated cost for the project and arrived with the amount of **EIGHT MILLION SIX HUNDRED TWELVE THOUSAND FIVE HUNDRED SIXTY-THREE PESOS (₱8,612,563.00)** as the Approved Budget for Contract (ABC);
- WHEREAS**, under the 2020 APP, the Mode of Procurement to be used is through **PUBLIC BIDDING**;
- WHEREAS**, the PSHS-MRC Bids and Award Committee through its Secretariat advertised/posted the invitation to bid with **Purchase Request No. 2020-08-PR063** for the project, **DESIGN AND BUILD SCHEME INFRASTRUCTURE PROJECT: COMPLETION OF WATER SYSTEM**, with an ABC of **EIGHT MILLION SIX HUNDRED TWELVE THOUSAND FIVE HUNDRED SIXTY-THREE PESOS (₱8,612,563.00)** in the PhilGEPS website, Agency Website, three (3) government agency's bulletin board and within the premises of PSHS-MRC as required by R.A. 9184;



**WHEREAS**, there were originally two (2) prospective bidders, **HATJR-MAINTENANCE & CONSTRUCTION SERVICES CORPORATION** and **ORIENTECH CONSTRUCTION AND DEVELOPMENT CORPORATION** handed their bidding documents on the last day of submission and opening of bid dated October 20, 2020 at 2:00 PM,

**WHEREAS**, during the verification of the technical documents, the bidder **ORIENTECH CONSTRUCTION AND DEVELOPMENT CORPORATION** was found ineligible for not complying to the terms of reference stated in the bidding documents and the bidder decided to withdraw its bid,

**WHEREAS**, on the other hand, **HATJR-MAINTENANCE & CONSTRUCTION SERVICES CORPORATION** passed the technical and financial eligibility and has the single calculated bid.

**WHEREAS**, it was found out that **HATJR-MAINTENANCE & CONSTRUCTION SERVICES CORPORATION** offered the bid amount as reflected in the detailed evaluation of bids conducted last October 21, 2020;
