The agency was not able to achieve the required 50%, since only the Site Development for 2023 with the Approved Budget of the Contract amounting to P 5,000,000.00 was recommended for award of contract on December 28, 2022 as per Management Committee Resolution No. 2022-020.

The procurement activity of Construction of Academic Building II with the Approved Budget of the Contract amounting to P 70,000,000.00 started on November 22, 2022, from posting to PHILGEPS, agency's website and conspicuous place reserved for this purpose in the premises of the procurement entity to bid opening of Bids. The process of procurement was followed, and it was found out that the lowest calculated bid was non-responsive during the post qualification. The Bids and Awards Committee (BAC) proceeded the conduct of post qualification to the next lowest bidder and it is still ongoing as of the preparation of this certification.

This Certification is being made in compliance with the Guidelines on the Grant of the Performance-Based Bonus for the Fiscal Year 2023, of the Administrative Order No. 25 Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems.
