TERMS OF REFERENCE

SUPPLY AND DELIVERY OF ONE (1) UNIT MOTOR VEHICLE (MINIBUS)

I. BACKGROUND

In compliance with Republic Act. No. 9184 known as the "Government Procurement Reform Act", the PSHS-MRC will be conducting a public bidding for the supply and delivery of one (1) unit motor vehicle (minibus).

II. OBJECTIVES

- 1. For mobility of PSHS-MRC personnel to conduct field validation, monitoring and evaluation, and attend to official functions to and from various official destinations.
- 2. To ensure more efficient delivery of quality services to PSHS-MRC clients through adequate transportation system.

III. APPROVED BUDGET FOR THE CONTRACT (ABC):

The Approved Budget for the Contract is Five Million Pesos (Php 5,000,00.00) inclusive of all taxes.

IV. BIDDER'S QUALIFICATIONS

Certification from Land Transportation Office (LTO) - accredited manufacturers and importer attesting to the availability of authorized dealers and service centers within Philippines for the last five (5) years.

V. DELIVERABLES

One (1) unit motor vehicle (minibus). It shall be a standard sized 6-wheeler enclosed vehicle intended for conveying passengers and/or hauling cargo, traditionally having a hydraulic center door (folding auto type), a luggage compartment (both outside and inside the vehicle) and an exclusive door for the driver (optional). The seating capacity ranges from 29 or more passengers, including the driver.

VII. OTHER REQUIREMENTS

- 1. Warranty Three (3) years on parts and service with replacement by the supplier free of cost/charge.
- 2. The supplier shall facilitate the registration of the vehicles with the LTO in the name of PSHS MRC (red/government plate) valid for three (3) years. The supplier shall ensure the extension of validity of conduction stickers in case of delay in the release of LTO registration documents/plates to enable PSHS MRC to use the vehicles.
- 3. One (1) year GSIS or Third-Party Liability motor vehicle insurance
- 4. Conduct of training for concerned personnel on minibus maintenance and troubleshooting for at least one (1) hour.
- 5. Free labor on preventive maintenance service within the first five thousand (5000) kilometers.
- 6. Dealers must have service centers in Metro Manila and nearby provinces.
- 7. AFTER SALES SERVICE
 - a. Submission of Certificate of After Sales Service, Manpower Requirements and Availability of spare parts within the warranty period with the list of accredited services centers in the Philippines, indicating the address, telephone numbers and contact persons.
 - b. Certificate of undertaking those spare parts be available 10 years from the date of acceptance.
- 8. Original Warranty/Guarantee Certificates shall be issued in the name of PSHS-MRC.
- 9. Distributorship Agreement shall be provided for the legitimacy of the supplier.
- 10. In the observance of COA Circular 1977-061: Provision of "For Official Use Only" sticker decal with the name of the office using it on each side of the motor vehicle and "Priority Seating" for each of the four reserved seats near the entrance door (see attached picture at the last page).

VIII. DELIVERY SCHEDULE

- 1. Delivery Period: The one (1) unit motor vehicle (minibus) must be delivered within **six (6) months maximum** upon the receipt of the Notice to Proceed (NTP).
- 2. Delivery Site: The motor vehicle (minibus) must be delivered at the address below:

3. Delivery should be made within office hours and on regular working days on or before the stipulated date in the contract unless otherwise specified for valid reason why the same cannot be complied with.

IX. INSPECTION, TESTING AND ACCEPTANCE

- 1. After Sales Service and Support during the warranty period, all reported defects shall be completely/satisfactorily repaired/replaced by the winning bidder/supplier within 72 hours after receipt of a verbal and/or written notice from the PSHS-MRC.
- 2. The PSHS-MRC shall have the right to reject and return the unit and cancel the corresponding Contract if units delivered are defective, incomplete, or non-compliant to the specifications herein specified.
- 3. All costs of testing (visual inspection, sideslip test, suspension test, roller brake test, speedometer test, headlight test, emissions test, sound test and smoke test) shall be for the account of the supplier.

X. TERMS OF PAYMENT

The payment shall be done within thirty (30) calendar days upon receipt, inspection and acceptance of the vehicle including documents such as Motor Vehicle Official Receipt and Certificate of Registration and other documents as may be required.
